Albania	The Albanian government is not planning to introduce recovery certificates.
Austria	AT is following the EU guidelines on Digital Green Certificates. Regulations are still being developed.
Belgium	BE is planning to issue certificates, e.g. recovery certificate will last for 90 days. BE will send the respective document, when officially confirmed.
Croatia	Recovery certificates are already accepted for travel purposes when traveling in Croatia up to 180 days.

Czech	Recovery certificates are already accepted on national level: when someone wants e.g. to visit some special service or football match it is possible to
Republic	verify by PCR test or recovery in the last 3 months.
Estonia	This issue is not under discussion at the moment.
Finland	Recovery certificates are still under discussion, but no decisions have been made yet.
Ireland	The Government recently confirmed that IE is following the European Commission's framework for a 'Digital Green Certificate', which includes the issuance and acceptance of certificates relating to recovery. At the moment, work is ongoing on the development of these Digital Green Certificates and IE is engaging in EU discussions. As of yet, no overarching policy has been decided on in relation to recovery certificates for travel purposes, and the
	public health restrictions that travelers presenting these certificates would be required to follow. We will likely see some development on this in the coming weeks and months. Overall it seems that Ireland intends to follow the EU framework for these certificates, while also considering the global epidemiological situation and public health advice on an ongoing basis. However, the regulations are still being worked on and no official decision has been made yet.
Malta	Data on reinfection risk is not strong enough to accept recovery certificates. MT intends to produce them for any Maltese residents travelling to countries that accept recovery certificates. MT is just not intending to accept them for local purposes.
Netherlands	There is no information available on recovery certificates yet.
Poland	Poland plans to accept recovery certificates for travel purposes based on the system of Digital Green Certificates, which implementation is planned in the EU in June 2021.
Slovenia	Recovery certificates are not decided yet, however, they are under discussion.
Spain	Recovery certificates are not decided yet, however, they are under discussion.
United Kingdom	Recovery certificates are being discussed at the moment, but still without a decision.
